Fees

This charter roster must be accompanied by payment:

- \$20.50 per new charter member (\$15.00 initiation fee + \$5.50 liability insurance fee)
- \$20.50 per "dual" member (a member currently on the roster of another Civitan club who is also joining the new club, therefore retaining multiple memberships)
- \$10.50 per reinstated member (\$5.00 reinstate fee + \$5.50 liability insurance fee)
- \$0.00 per transferred member, or former Junior or Campus Civitan member

Sponsor Credit

Credit for sponsoring the charter member should go to the person who is responsible for recruiting the member into the club. Charter members may sponsor other charter members, however, a member may not sponsor himself/herself. Only one sponsor may be shown for each member.

Additional Charter Members

Charter members may continue to be added to the club for up to two weeks following the charter date. After that time, any new members are considered traditional new member additions, and will not be considered charter members.

Roster Limitations

A new club's roster may not be comprised of more than 20% members who are transfers, reinstates or dual members.

Half-Dues

Members qualifying for half-dues status at billing cycle (but still required to pay full initiation fee) include:

- Full-time students
- Individuals with Intellectual & Developmental Disabilities
